

## Privacy Policy

Your privacy is important to us. ## Information We Collect

**Cookies:** We may use cookies to collect information about your browsing behavior, which helps us improve our website's functionality and user experience. You can learn more about our use of cookies in our Cookie Policy.

## How We Use Your Information

We may use the information we collect for the following purposes:

**Providing Services:** To provide our spa services and respond to your inquiries.

**Communication:** To send you important updates and promotional materials related to Aspire Med Spa & Beauty Bar. You can opt out of receiving promotional communications at any time.

**Website Improvement:** To analyze and improve our website's content and user experience.

## Sharing Your Information

We do not share or sell your Personally Identifiable Information to third parties for marketing purposes. No mobile information will be shared with third parties/affiliates for marketing/promotional purposes. However, we may share your information in the following circumstances:

**Business Operations:** We may share your information with third-party service providers who assist us in business functions such as payment processing, customer support, and website maintenance.

**Compliance with Legal Requirements:** We may disclose your information when required by law or to comply with legal processes.

**Sale or Merger:** In the event of a sale, merger, or acquisition of Aspire Med Spa & Beauty Bar, your information may be transferred to the acquiring company, but it will continue to be protected in accordance with this privacy policy.

## Security of Your Personal Information

## How Long We Keep Your Personal Information

If necessary, we may retain your personal information for legal, accounting, or reporting obligations.

## Children's Privacy

We do not target or collect personal information from children under 13 years of age.

## International Transfers of Personal Information

Your personal information may be stored and processed in locations that may not have the same data protection laws as your country of residence. If we transfer your information to third parties in other countries, we will do so in accordance with applicable law and ensure it is protected in line with this policy.

## Your Rights and Controlling Your Personal Information

You have the right to:

**Rectification:** Request corrections to any inaccuracies in your personal information.

Deletion: Request the deletion of your personal information, subject to legal obligations.

Data Portability: Request a copy of your personal information in a structured, machine-readable format.

You also have the right to withdraw your consent for the use of your personal information for direct marketing purposes at any time.

If you believe that any information we hold about you is inaccurate, incomplete, or outdated, please contact us to request corrections. If you believe we have violated any data protection law, you have the right to lodge a complaint with a relevant authority.
